

OFFICIAL'S CLINICS

PROCEDURES FOR HOSTING YOUR OWN CLINIC

Based on the continued growth of the Carolina Region, clubs and/or teams are encouraged to host their own Referees and Scorekeepers clinics each season to ease the burden at Region-sponsored clinics and to allow clubs to finish their requirements earlier. These procedures should make it easier to host:

(1) Arrange a Site, Date, and Time to hold your clinic. Most clinics should take between 4-5 hours, not including scheduled breaks and tests. The clinicians will administer the tests and grade them on-site (so your players will be done when they leave the site)! If you can provide a screen and projector that is helpful as the clinic is on PowerPoint (some clinicians may have their own so be sure to communicate with your clinician about their needs).

(2) Estimate the number of participants that will be involved at your clinic. Please consider opening it up to outside teams/clubs. The Region recommends a charge of \$5 per person for outside participants to help defray your costs.

(3) Contact Approved Clinicians from the list below to see if they will do your clinic. The Region limits class size to 50 participants per clinician. Thus, if you have less than 50 participants, then you could have one Clinician. If you have 50-100 participants, then at least two Clinicians are needed (contact Marilyn at officials@carolinaregionvb.org or 919.631.3737 for help in determining number of clinicians needed). NOTE: Clinicians may not accept a clinic on a date that a Region-sponsored clinic is being held unless approved by Marilyn. We need to cover the Region clinics first.

(4) There are no reporting requirements by the club/team to the Carolina Region! The clinician is responsible for reporting to the Region that they will be holding a clinic for a particular club/team. The clinician will be required to report all results of the clinic to the Region within seven days of the clinic. If the clinician fails to follow this procedure, then they may lose their right to give sanctioned clinics for the Region in the future. The club/team must pay the clinician on-site at the negotiated rate agreed by both parties before the clinic. The Carolina Region recommends Clinician Fees of \$200 per clinician for a full clinic and \$125 for a re-cert clinic (plus any travel, food, and copying costs requested by clinician); however, clinicians may negotiate their own fee higher or lower. Clinicians are Independent Contractors and are not employed by the Carolina Region.

(5) Although clinicians are the reporting agency now, if you want your clinic posted on our website as open to other clubs/teams it is requested you send an email to the Carolina Region (office@carolinaregionvb.org) with the details so it can be posted in a timely manner. If you have any questions, please contact Marilyn at officials@carolinaregionvb.org.
