

APPROVED UNIFORM FOR USA VOLLEYBALL CERTIFIED REFEREES AND SCOREKEEPERS

The only uniform authorized to be worn at USA Volleyball-sanctioned competitions and those competitions where certified USA Volleyball officials are assigned shall be:

Shirt: The USA Volleyball uniform shirt will be all white with the following: approved official embroidered designation on the left sleeve, Velcro patch on the right side of the chest, and an optional pocket on the left side of the chest. Complete specifications regarding the uniform shirt are available from the vice president, Officials Division, USA Volleyball. The only fabrics (weight and type) and styles allowed are those approved by the USA Volleyball Officials Division. The approved logo for the uniform shirt is protected by copyright. The approved official uniform shirt shall display only the logo and emblem as noted herein. Any other emblem, logo, inscription and/or personal identification is not authorized in sanctioned USA Volleyball competition, or in competition where an official is representing USA Volleyball.

Pants: Dark navy slacks. No denim or riveted clothing.

Belt: If a belt is worn, it shall be black or dark navy blue in color.

Shoes: White (to be worn with white socks).

Jacket: (Optional wear) All white or blue, with nylon knit trim, matching knit collar and cuffs. Twin slash pockets with matching drawstring waist. Snap front. May be lined or unlined. Official USA Volleyball logo containing lettering "certified official" will be on left chest.

Sweater: (Optional wear) White V-neck pullover sweater shirt. Official USA Volleyball logo containing lettering "certified official" on the left chest. This is authorized as official outside wear in sanctioned matches for official's comfort at appropriate tournament sites.

Shorts: (May be worn at the option of the event organizer) Dark navy blue. Solid white crew socks or solid white anklets will be worn.

Patch: Only currently approved certification patches shall be displayed and shall be placed on the right chest, unless otherwise specifically approved by the Officials Division. USA Volleyball certification patches may be ordered from the RVA referee and/or scorekeeper chairs (Provisional and Regional referee and scorekeeper patches) or the assistant vice president, USA National Referee Commission (junior national and USA national referee patches) or the assistant vice president, USA National Scorekeeper Commission (junior national and USA national scorekeeper patches).
