







Were you at a tournament where a Referee used a Purple Card to address spectator behavior?



Officials Clinics

Club-hosted, in-person officiating clinics can be very large, difficult to schedule for both the club and our limited number of clinicians. We are considering limiting inperson officiating clinics to the 14 and under age groups and coaches. The 15 and older age groups would take the clinic online. NOTE - USAV has indicated they will be revising their online junior referee training curriculum, so the hope is these will be a much better training experience in the future.

2019 Survey Final Comments

- We like the point system that Carolina Region utilizes. The region provides timely responses to questions that I have throughout the season and that is much appreciated.
- I suggest we allow extra points for the teams that advance to tournament bracket play (semis). There is no reward for making it to the semis... Teams that advance to the semis and lose could lose points that would potentially put them in a worse tournament position than those not making the semis. Should be some bonus for advancement.
- Like the way the refs R1 the playoffs of the local tournaments but they need to work on the consistency of calling doubles. If the refs are going to call a tighter game then they need to work with the team refs during the day to make the same calls. I do not mind the calls but when you have not called them all day and my ladies start imitating the other team pushing a ball iver, etc and then you start calling it, it is hard to explain to them and then parents. I feel the refs did a great job but we need a little more consistency to make the teams refs better overall

2019 Survey Final Comments:

- I would like to see no team movement for Regionals. This year our last tournament we lost in semi-finals but because we gained points we had to move up for Regionals
- Nope, things went smoothly.
- I was personally disappointed in the adult refs and some of the 14 teams with the officiating. Showed the rule book to 2 to prove they made an incorrect call (didn't allow 2 chance to serve for 14's). Didn't allow 2 minute warm up period after coin toss for first game of day.
- Referee's call games very differently. Sometimes making calls in their words "To Set The Tone". Younger referees are biased and inconsistent. This was a tough season for players and coaches where referee's dictated the outcome of the matches.
- no. Thank you and CR for all you do. I thought the officiating was very consistent all year and we appreciate all the host sights. Thanks again
- Had a wonderful season this year with all teams friendly and helpful.
- I do not at all like that only first and second play after morning play. It makes their day so much shorter.

2019 Survey Final Comments:

- The U12 group gets tournaments in Mayodan every year. For many of us in the east this requires a hotel stay. We shouldn't need to do a hotel stay for any in region tournament. The region should do a better job of looking for tournament locations that are more central to the majority of the division.
- For the 12s level, please make sure all referees understand the serving line rules beginning at the first tournament. We had some inconsistencies.
- Have all the refs be consistent with their calls. I don't care the age group. In order for players to improve, they HAVE to penalized for double hits. Region championships was a joke in that no doubles were called (14 East Division 1).
- We do not want to play at local other big club facilities, they had recruited players from other clubs during the tournament if we have a choice to where we want to play. maybe cross regions.

Club Tryouts-Proposed

Tryouts:

There will be TWO announced Girls' tryout periods that clubs are encouraged but not required to adopt. (1) The FIRST tryout period will begin on **Saturday October 26, 2019** for the following age groups: **U14**, **U13**, and **U12**. (2) The SECOND tryout period for the **U15**, **U16**, **U17**, and **U18** age groups will begin **Sunday**, **November 10**, **2019** (after the North Carolina State Championships for public High Schools on November 9, 2019). The Carolina Region/USAV will not publish any tryouts for girls' teams on its website that occur before these dates for the respective age groups. Some middle and private school seasons can last longer than the High School season so the Region recommends club directors check with Middle and/or private school coaches in their area to determine optimum tryout dates for their various age groups.

Signing Date:

Clubs are encouraged to allow players the opportunity to attend more than one club's tryouts. The Carolina Region requires that clubs adopt a signing date of 6:00 pm FRIDAY following the initial beginning tryout date: SIX DAYS - Nov. 1, 2019 at 6 pm after the FIRST Tryout Period begins for the U12, U13, and U14 age groups and FIVE DAYS - Nov. 15, 2019 at 6 pm after the SECOND Tryout Period begins for the U15, U16, U17, and U18 age groups. Clubs must hold an offer open to a player to join a particular team in the club or the club in general until the respective age group signing date. If a player commits by the signing date, clubs must honor their commitment or the club may be considered to have violated the RVA/USAV Code of Conduct. *Players may voluntarily commit to a club at anytime following the club's tryouts, but should not be pressured to do so.* For tryouts held just before or after the signing date, clubs should give a minimum waiting period of seven days before requiring a player to commit to their club. The Carolina Region *Letter of Commitment* when accepting players into their clubs. This form should not be sent to the Carolina Region, but kept on file with the club should any question arise about a player's commitment to a club or a club's commitment to a club or a club's commitment to a player.
