- I. - III. Kevin reviewed items discussed and approved at the recent Carolina Region Board of Director meeting that are of interest to officials:

- VI. Registration Updates 2022 Registrations will be available September 1. Individuals will go through the quizzard which will guide them to the correct membership. There is a dedicated membership for Professional officials. Once you select that, it will include all requirements you need to complete (SafeSport, Background Screen, Independent Contractor Agreement). The Background Screen is now \$14. Region will still pay for our officials as long as you follow our instructions. Wait for our email with instructions before registering for the 2022 season. Brian wants everyone to register early so you can begin working on your eligibility requirements and the clinics. We will auto-enroll everyone once again in their clinics.
- VII. Region Clinics Brian is working on the dates now for in-person and online meetings for New officials. We will post the update on our Clinics page once they are finalized. The need for officials is still great. Help us recruit new officials as you come across any that have good potential. A question was asked if we are still using Junior referees. Yes, we are still actively recruiting anyone 16 or older to work. Many juniors join us each season to work on their off weekends.
- VIII. SafeSport SafeSport is required for all Officials. This will need to be completed before you are marked as eligible in the USAV system. When you register as an official, you will be enrolled automatically in the SafeSport course that applies to you this season. There are three courses now Core, Refresher 1, and Refresher 2.
- IX. 2022 Season Formats Current plans are to hold regular 4-team pool tournaments for our one-day tournaments. All this will be dependent on the current status of COVID in the state and our ability to get facilities. We will update officials of any updates or changes as we approach the season. Be prepared to be flexible.
- X. Assignments and Payments We will use ArbiterSports and Arbiter Pay again this season. Contact Brian if you need help in setting up your accounts and affiliating with the Carolina Region.
